Cheers to 50 Years!

This year, HIP Housing celebrates its 50th anniversary. Founded in August 1972, we have grown from a small nonprofit of 10 people operating out of an office at a local bank, to a premier San Mateo County affordable housing agency with two offices and more than 40 staff.

"It's wonderful to see how far we've come!" says Lois Almen Everett, HIP Housing's founder. "From a \$20,000 grant to start our Home Sharing Program, to a staff of more than 40, HIP Housing has surpassed my wildest dreams. And there is still a lot left to do!"

Every year, our agency serves more than 1,200 people in need of affordable housing in San Mateo County through our Home Sharing Program, Self Sufficiency Program, and Property Management Division...and we continue to grow! Our property management team recently added Affordable and Inclusionary Housing Compliance Services, to serve property owners and developers required to include below market rate units in their developments. Our new Self Sufficiency Program's Nurturing Fathers Initiative is up and running, and we hope to launch a new Information and Referral Services Program later this year.

"We are so proud to reach our 50th year milestone!" says Kate Comfort Harr, HIP Housing's Executive Director. "Our work has helped tens of thousands of people to live healthier, more independent lives by creating affordable housing opportunities in our County. While we look to the past to celebrate, I am so excited about everything we

have coming next!"

Staff members helped each visitor find their gifts while the sound of laughter and conversation filled the air. Kids had the chance to select a special treat from the enormous box of cookies provided by long-time HIP Housing partner, Cake 4 Kids.

Organized by Regina Greissinger, Self Sufficiency Program Administrative Manager, the Adopt A Family Program has been a hallmark of the holiday season at HIP Housing for 20 years. Donors may choose to purchase gifts for a family from a wish list, or simply make a donation to the program.

"Adopt A Family provides families and seniors in HIP Housing programs and properties with extra support during the holiday season," says Ms. Greissinger. "Warm coats, shoes, and bedding, as well as other essentials that a family might need, make all the difference during the winter months."

The 2021 Adopt A Family Program served 86 families in December. While many of the families are current Self Sufficiency Program clients, SSP graduates are also eligible to participate, as are families who reside in our agency's affordable housing properties. All 279 residents at HIP Housing's senior properties in San Mateo also participated in the 2021 Adopt A Family Program.
